WHEREAS, the BAC ON 29 November, convened and deliberated upon the status of janitorial services and was prompted by the Audit Observation Memorandum 2011-001 dated 13 October 2011;

WHEREAS, on 5 March 2012, due to the fact that there was only one (1) bidder for janitorial services – Cancu General Services, the Committee declared the first failure of bid (Bid proposal submitted by the lone bidder for janitorial services remained unopened/sealed and considered to be included in the next bidding schedule;

WHEREAS, on 06 March 2012, the BAC re-post the Announcement of the Bidding for Janitorial Services in Philgeps, PCOO Websites and three (3) conspicuous places;


WHEREAS, on 22 March 2012, the bidders submitted their bid proposals and at 10:01 am the BAC opened the bid proposal;

WHEREAS, during the opening of bids on 22 March 2012, two bidders submitted their respective sealed bid proposal which were opened in their presence. The Committee informed the two (2) bidders that after the evaluation they will be informed whoever is the winning bidder;

WHEREAS, the TWG convened, and conducted the post evaluation of bid proposal submitted by the bidders. After a thorough review and evaluation of subject documents, the Committee decided to consider CANCU ENTERPRISES AND GENERAL SERVICES, INC. as the winning bidder which quoted the lowest bid in the amount of ONE MILLION SEVENTY FOUR THOUSAND NINE HUNDRED EIGHTY FIVE AND 20/100 (P1,074,985.20.)

NOW, THEREFORE, the foregoing considered the PCOO-Proper BAC hereby recommends to the Secretary to enter into a contract with CANCU ENTERPRISES AND GENERAL SERVICES INC. for the Supply of Janitorial Services. The corresponding Notice of Award will be issued upon approval of this Resolution while Notice to Proceed will be issued within three (3) calendar days from the date of approval.
