## PCOO BIDS AND AWARDS COMMITTEE RESOLUTION NO. 005 Series of 2012

WHEREAS, the PCOO Bids and Awards Committee (BAC), on 29 November 2011, convened and deliberated upon the status for security services prompted by the COA Audit Observation Memorandum 2011-001 dated 13 October 2011;

WHEREAS, on 13 February 2012, the Bidding for Security Services was announced and posted in Philgeps, PCOO websites and three (3) conspicuous places;

WHEREAS, on 5 March 2012, only one (1) bidder for security services participated which caused the BAC to declare a failure of bidding (bid proposal submitted by the lone bidder for security services remained unopened/sealed and considered to be included in the next bidding schedule;

WHEREAS, on 6 March 2012, the BAC reposted the announcement of the second bidding for security services in Philgeps, PCOO websites and three (3) conspicuous places;

WHEREAS, on 22 March 2012, only one (1) bidder for security services participated, which prompted the BAC to declare a failure of bidding for the second time;

WHEREAS, after two (2) failed biddings, the BAC, in a meeting on 22 March 2012, resolved to enter into a negotiated procurement for security service pursuant to Section 53, Rule XVI of Republic Act No. 9184;

WHEREAS, after thorough negotiations with Protectors of Assets and Personnel Services, Inc., representatives from Protectors and the PCOO BAC agreed on the terms and amount for the contract;

WHEREAS, after concluding the negotiations, the BAC decided to award the contract to Protectors of Assets and Personnel Services, Inc. in the amount of TWO MILLION FOUR HUNDRED EIGHTY EIGHT THOUSAND FOUR HUNDRED FIFTY FIVE PESOS AND THIRTY SIX CENTAVOS (P 2,488,455.36).

NOW THEREFORE, having considered the forgoing circumstances, the PCOO BAC hereby recommends to the Secretary to award the contract for the procurement of security services to **PROTECTORS OF ASSETS AND PERSONNEL SERVICES, INC.** The corresponding Notice of Award will be issued upon approval of the Secretary while the Notice to Proceed will be issued within three (3) calendar days from the date of approval.
