Eligibility Requirements	Clarification on the requirement of submission of Audited Financial Statement (AFS).	The Bids and Awards Committee requires the AFS as supporting document of the NFCC for validation of its computation.
Eligibility Requirements	Whether the Committee requires the submission of additional attachments in the Technical Specifications.	All other documents stated in the Technical Specifications which are <i>not</i> part of the checklist of requirements shall be submitted only as post-qualification requirement by the bidder to be declared as having the Lowest Calculated Bid .
Eligibility Requirements	Clarification on the submission of additional attachments on Statement of On-going contract.	Attachments on the Statement of On-going contract is not required.
Price Schedule Form	What is the basis of the PhilHealth computation is it the latest FY 2022 computation of four percent (4%) or the existing three percent (3%)?	The existing rate as required by the Department of Labor and Employment shall be the basis of the computation.
Financial Bid Form	Whether the janitors shall be required to report on Monday-Friday or Monday-Saturday.	The janitors shall be required to report from Monday – Saturday including holidays.
Financial Bid Form	Clarification on the Financial Bid computation	The bidder shall bid for a period of twelve (12) months. The bids will be divided by said number of months in order to determine the monthly rate.
