| Clarification whether there is a need to attached supporting document for List of all ongoing contract | No, please note only the SLCC requires attachment of proof document |
| Clarification whether bidder's that are bidding for multiple lot should submit eligibility separately per lot or will one suffice | One submission will suffice provided that the lot participated for is stated and for eligibility documents that require the input of the procurement/ contract lot no. is properly reflected in the lot which the bidder is participating |
| Clarification on where to find the templates and guideline | In the invitation to Bid a link is provided which includes the guideline for the hybrid bidding procedure and preparation of eligibility document, and the GPPB and PCO provided template. https://drive.google.com/drive/folders/1dcyf2k9fCCyeLhFE9j8i5hXVprjWBQKv?usp=drive_link |
| Clarification for number of copies for manual submission | 3 copies (1 original and 2 copies) |
| Clarification if there are any color-coding requirements for folder | No |
| Clarification whether to put all lots in price schedule even if the bidder is only bidding for certain lots. | No, specify the lot you are bidding for |
| Clarification whether to put lot as a quantity or should it be breakdown | Price schedule should be filled up based on item so that the breakdown of costing including its incidental cost may be specified |
| Request for the removal of Scalable Storage from the specifications | The technical specification would remain the same |
